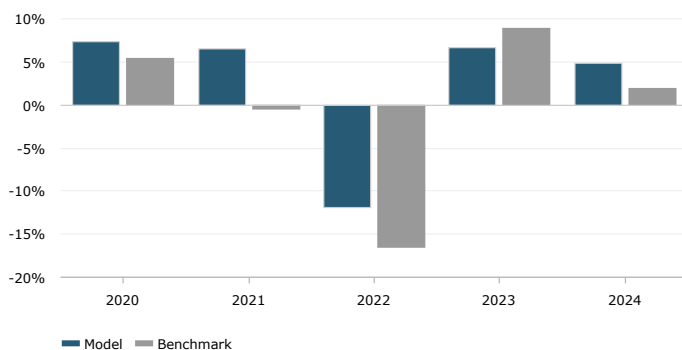

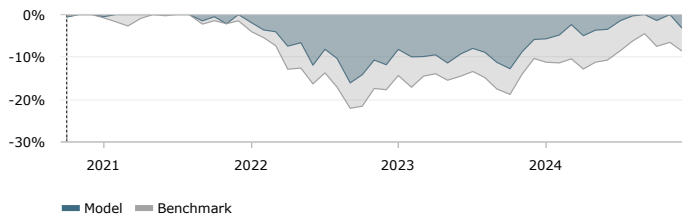

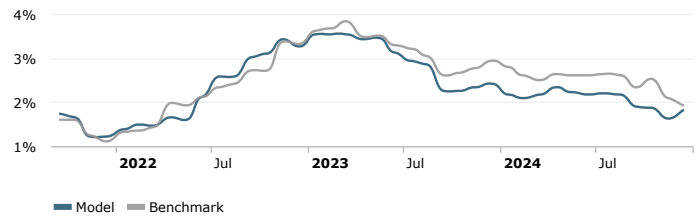

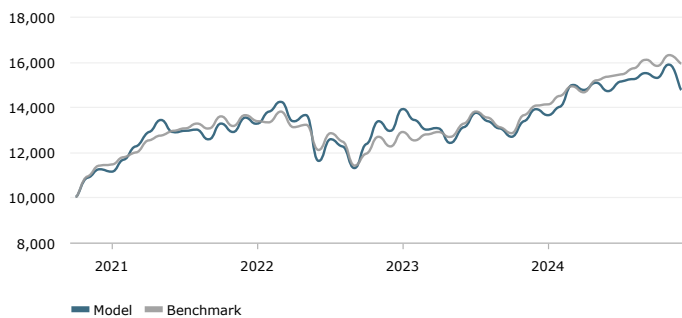

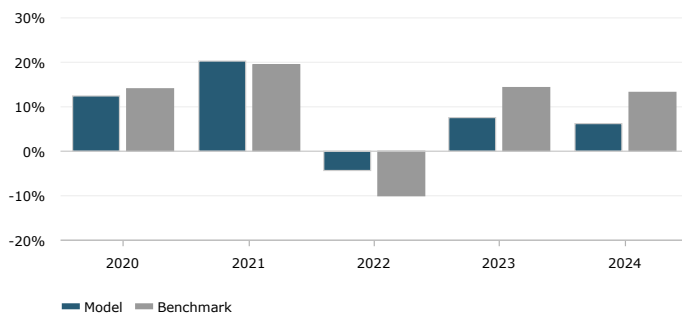
Astoria's Inflation Sensitive Strategy targets funds that are sensitive to rising inflation, such as:

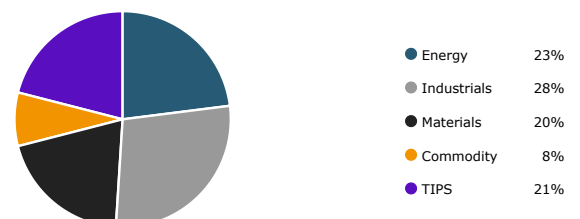

Multi-Asset Risk Strategy ETF Portfolio



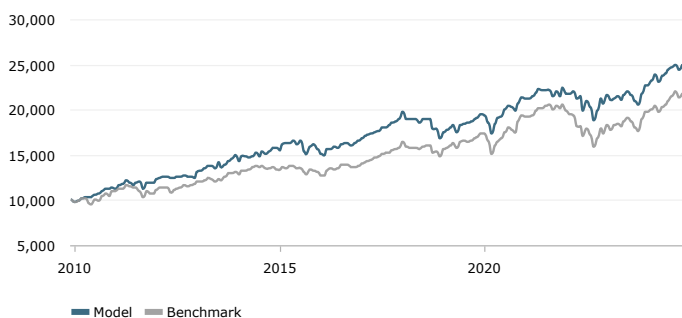

Astoria's Multi-Asset Risk Strategy focuses on long term growth by blending various equity factors along with allocations to fixed income and alternatives.

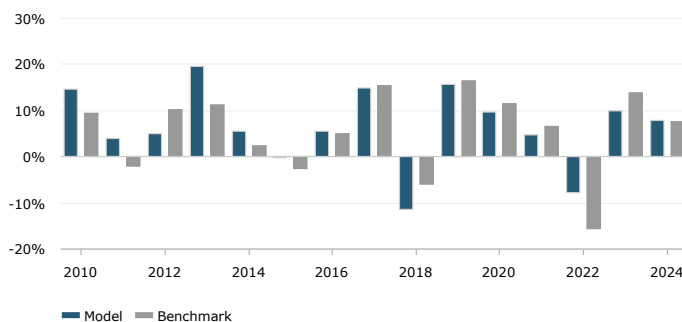

There is generally one or two strategic rebalances per year assuming normal market conditions.

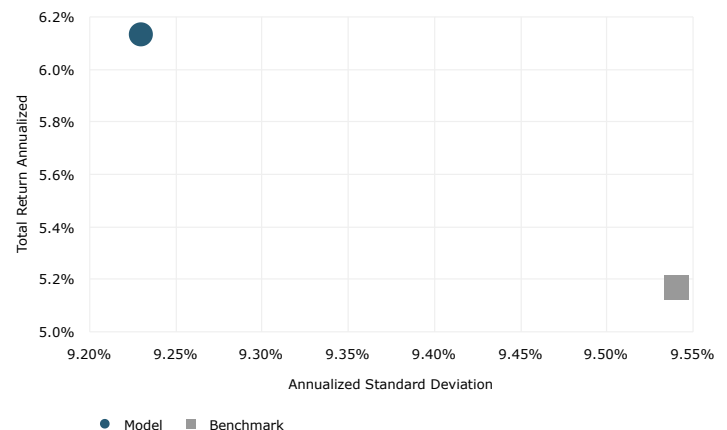

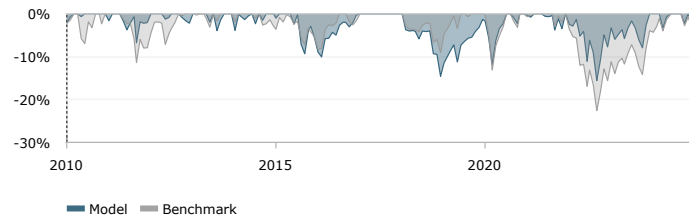

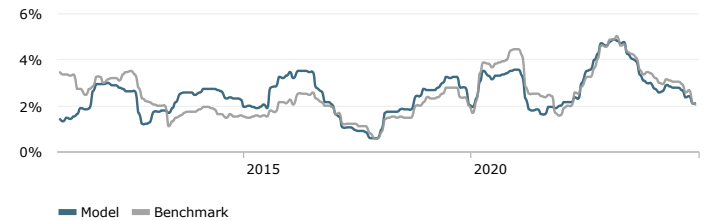
